CALL TO ORDER

The meeting was called to order at 1:04 p.m. by Commissioner Teal.

CONSENT AGENDA

EXECUTIVE DIRECTOR'S REPORT

Executive Director Martinez presented a written report and asked if there were any questions prior to proceeding with her verbal report.

Executive Director Martinez began with discussion following up to last month's request from Commissioners regarding how Housing Authorities in other Counties handle public interaction and questions directed to the Board of Directors. Most HA's have information on their website directing the public to their Human Resources contact which in turn will contact the board with questions and or concerns. Additionally, other HA's include language on their website encouraging the public to attend meetings. The PHA board members agreed this is the best way to handle any questions directed to the Board of Directors from the public, approving this process.

Executive Director Martinez addressed the replacement of Director of Asset Management, this will not be a replacement but rather a small re-organization which has been incorporated into the FY2021 budget. The plan will save the cost center \$30,000 in wages by reducing management salaries, adding 2 new positions within programs, eliminating 2 existing management positions and creating 1 new position, replacing 1 position in a program that has been vacant for approximately 2 years, giving more support in Section 8. This will help to handle the additional workload ahead with the RAD conversion and the Voluntary Streamline Conversion. A new PHA organizational chart will be created showing changes.

REPORTS FROM COMMISSIONERS

Commissioner Turner stated, it has been a big week at the Boys and Girls Club, the walls have been completed on the gymnasium and things are moving along nicely. Youth of the Year has been awarded to one of the Port Angeles Boys and Girls Club Youths for the second year in a row, what an honor.

Commissioner Tinker reported the local Veterans Association Clinic will visit Sarge's Place and test all tenants and staff for Covid-19 at no cost. United Way has announced they have received funds through a consolidated homeless grant to assist Clallam County veterans and widows of veterans in need of rental assistance.

Commissioner Richardson reported Dove House Recovery Café continues construction slowly with social distancing safeguards in place.

Commissioner Lindholm had no significant updates

Commissioner Fellin had no significant updates

Commissioner Shusterman had no significant updates

Commissioner Teal informed the board the Habitat home next door to her has begun construction again, she is hoping to have a new neighbor soon.
