#### **CONSENT AGENDA**

Approval of consent agenda:

#### EXECUTIVE DIRECTOR'S REPORT

Executive Director Martinez reported on the progress of Public Plaza. The surveys revealed encroachments. The building to the east of the Lee Plaza encroaches over the property line. There appears to be a party wall agreement in place. The fence belonging to the neighbor to the east of the Villa is about 10" onto PHA property which the title company will most likely insure, however the fence may need to be repaired or rebuilt. The Manor has an encroachment from the eve of the house to the west and its fence which is in the right of way, again the title company will likely insure. The Terrace has an encroachment from the Westside Pizza propane tanks. The City of Port Angeles and PHA are working with the owner to facilitate moving them. Director Martinez indicated the cost estimate from BELFOR came in as expected. Commissioner Teal asked about an update regarding Phoenix Addition. Annie O'Rourke, Director of Acquisition & Development reported moving forward on two lots. Habitat for Humanity is not selling the lots they own at this time. Commissioner Turner asked about feasibility on the 8<sup>th</sup> Street property. Annie O'Rourke replied, it's all about timing and cost. Commissioner Teal asked Director Martinez about the public hearing for HB1590 with Jefferson County Commissioners. Director Martinez stated a

hearing date is scheduled Dec. 21, 2020. Director Martinez mentioned receiving an email from the Olympic View Community Foundation offering refurbished computers to those who are in need but cannot afford to buy. The resident service coordinator for the PHA was able to get three computers for our clients. Additionally, PHA has received official notification of its award for 10 additional VASH youchers.
