#### EXECUTIVE DIRECTOR'S REPORT

Executive Director Martinez reported participating in a meeting discussing the use of ARPA funds in Clallam County for immediate and long-term housing needs. Discussed All View Motel is on the market and Peninsula Behavioral Health is interested in purchasing and rehabilitation for affordable housing. Discussed ARPA funding in Jefferson County. High demands for work force housing. High rental cost and no vacancies is an ongoing issue in Jefferson County. The Public Plaza rehabilitation is underway at the Manor and Villa Buildings. Staff is working with residents for temporary relocation.

#### REPORTS FROM COMMISSIONERS

Commissioner Tinker: Received building permits for Hobucket for foundation work beginning in August 2021. On a short list for an appropriation of a \$900,000 Grant awaiting Murray's approval. Grant to provide a 7-bedroom group home in Sequim.

Commissioner Turner: Reported that TAFY received funding to specifically serve homeless mothers and children. Working with a local Church establish tiny homes in parking lot. Boys & Girls Club playground complete.

Commissioner Robinson: Humanity for Habitat, waiting on surveyor for Sequim Project. Discussed with Port Angeles City Council about our Senior Aging in Place Program which assists those who need modifications to their home in order to age in place.

Commissioner Teal: Attended Affordable Housing Task Force meeting and the Shelter Strategy meetings. Fairgrounds still being used for Tent Encampment while other options are researched.

Commissioner Webster: Attended a webinar about house sharing.

Commissioner Felin: No significant updates.
