#### EXECUTIVE DIRECTOR'S REPORT

Executive Director Martinez discussed affordable housing with the Interim City Manager in Sequim. The Director of Development, Annie O'Rourke had received an email from Community Frameworks, the PHA's partner in Self-Help, with some information regarding some land for sale. This land would hold up to 60 to 70 Self-Help Houses. Director Martinez will continue to work with the City of Sequim to acquire and develop the property – there was preliminary discussion of a PRD for some Self-Help development and/or lot sales. Director Martinez gave a presentation at Coffee with Colleen with Clallam County Community Development and Economic Council. Director Martinez also gave a presentation to Jefferson County Commissioners on Monday, September 13<sup>th</sup> about PHA programs. Martinez will be on schedule to give Jefferson County Homeless and Affordable Housing Taskforce a presentation in November 2021. Was contacted by Port Angeles City Council member Schromen-Wawrin to discuss

helping Clallam County enact the 1590 1/10<sup>th</sup> tax increase to benefit Affordable Housing. Update-All View didn't get funded in phase 1 because the rehabilitation is too significant. Working on Phase 2 for funding which will be available in December.
