Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA’s operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA’s mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

The PHA was approved for Streamline Voluntary Conversion in February 2021. The PHA has completed conversion of WA00400002 and has begun the mixed-finance rehabilitation; work is scheduled to be completed by October 2022. The PHA is anticipating conversion of WA004000001 in June 2022. Both projects will remain as affordable housing.</p> <p>32 project-based vouchers were awarded under the 10% Program Cap Exception Category to OlyCAP for use in Jefferson County. These vouchers will be provided to support homeless and special needs households in a new construction mixed-finance multi-family development. Construction began in November of 2021 and lease up is scheduled to occur in fall of 2023.</p>
B.3	<p>Progress Report.</p> <p>Provide a description of the PHA's progress in meeting its Mission and Goals described in the PHA 5-Year Plan. The Mission of the Peninsula Housing Authority is to promote safe, affordable housing and foster effective partnerships that help meet that goal.</p> <p><u>Update on Strategic Plan Goals</u></p> <ol style="list-style-type: none"> 1. Asset Management <u>Public Housing Repositioning</u> – The PHA continues to work through its Public Housing repositioning project. We successfully repositioned (WA004-000002)170 Public Housing Units through a Streamline Voluntary Conversion in May of 2021 and the buildings are currently undergoing rehabilitation for preservation of affordable units addressing long term deferred maintenance. WA004-000001 has 67 remaining Public Housing units which are part of a Planned Residential Development approved by the City of Port Angeles. We anticipate conversion through Streamline Voluntary Conversion in June of 2022. Upon SVC conversion residents will receive a TPV and can either remain in their unit or with assistance from the PHA relocate to a new unit in the community. The PHA plans to dispose of and demolish the units and rebuild, doubling the unit count utilizing 4% and 9% Low Income Housing Tax Credits as part of the PHA's long term redevelopment plan. The PHA would enter a Tax Credit Partnership and retain ownership of the asset. Relocation of residents who chose to stay would occur prior to demolition. Residents would have the opportunity to return to newly constructed affordable unit. Upon conversion of the remaining 67 public housing units the PHA will close out is Public Housing Program. 2. Acquisitions and Development <u>Mutual Self-Help Housing</u> – the agency continues to build 8-10 single family homes annually in Clallam and Jefferson counties through the Mutual Self-Help Housing Program operated in conjunction with USDA Rural Development. There is a current building group in Port Angeles and Forks. The next groups will be building in Port Angeles in Clallam County and in Port Townsend in Jefferson County. <u>Investigation into forming a 501(c)3 organization</u> – The PHA has begun exploring its options for forming a 501(c)3 to be used primarily to obtain private foundation funding to support PHA programs as well as a way for donors to make tax-deductible donations to the PHA. 3. Rental Assistance and Programing – The agency continues to work expanding housing opportunities with our partners to better serve both Clallam and Jefferson counties. OlyCAP, a two-county non-profit agency was awarded 32 Project Based Housing Choice Vouchers for a mixed-finance homeless/disabled property they are constructing in Port Townsend, Jefferson County, WA. Construction is underway and scheduled to be completed by the end of 2023. 4. Fiscal Sustainability – The PHA regularly evaluates opportunities to improve operating efficiencies, diversify the agency's portfolio, and seek funding resources to reduce the impacts when program funding is reduced. Repositioning has provided the PHA with significant stability and will allow us to continue to develop new housing. 5. Administration – The PHA continues to invest in employee training opportunities, improving client opportunities and employee job satisfaction. The significant information technology upgrades we have implemented over the last year have improved efficiencies greatly for the PHA. We will continue working on those IT upgrades which includes selecting a vendor to provide managed IT services and assist in streamlining our IT processes.
