The meeting was called to order at 1:04 pm by Commissioner Webster.

EXECUTIVE DIRECTOR'S REPORT

Director of Development Annie O'Rourke sat in for Executive Director Martinez at the April Clallam County Housing Solutions Committee meeting. There was good discussion surrounding the RFP for 1406 and 1590 funds, and it was ultimately determined the RFP was not ready for approval by the HSC and required more work. Director O'Rourke and Timothy Dalton are working together to revise it until it is ready to be sent to the RFP Committee, who will review it and make recommendations to the Housing Solutions Committee for any further updates. PHA will be receiving a Live United award at the United Way of Clallam County's May 13th Live United Prom. Commissioners Robinson and Tinker will be accepting on behalf of Director Martinez. Director Martinez and Director of Housing Debbi Tesch attended the April 16th Connectivity Fair in Jefferson County, the goal of which was to bolster inter-agency awareness and cooperation for members of the public. Director Martinez attended the April 13th ribbon cutting for Dawn View Apartments - formerly the All View Motel, purchased and converted by Peninsula Behavioral Health. PHA is ready to apply for the Continuing Affordability Grant when NOFOs are rolled out, which is anticipated to be in June.

REPORTS FROM COMMISSIONERS

Commissioner Teal: Attended OlyCap's 7th Haven ribbon cutting, along with Commissioner Webster and Director of Housing Tesch. Also noticed two lots for sale for \$95k on 22nd and Cliff St.

Commissioner Fellin: No significant updates.

Commissioner Turner: No significant updates.

Commissioner Tinker: NORVHN purchased the old VFW Hall across from the Forks post office and is currently moving in. It will expand their footprint to approximately 3,000 sq ft.

Commissioner Brotherton: No significant updates.

Commissioner Webster: Jefferson County recently formed a Coordinated Entry Advisory Board. They will be reaching out to PHA with a data sharing agreement to help in the collection and coordination of information across multiple housing providers and nonprofit organizations. Attended a meeting for the Housing Solutions Network. Commissioner Webster is also providing her assistance in data analysis and recommendations for emergency shelter and transitional supportive housing. The state of WA recently released projected housing needs by income level, highlighting vast local need for accelerated progress in development of more affordable housing.
